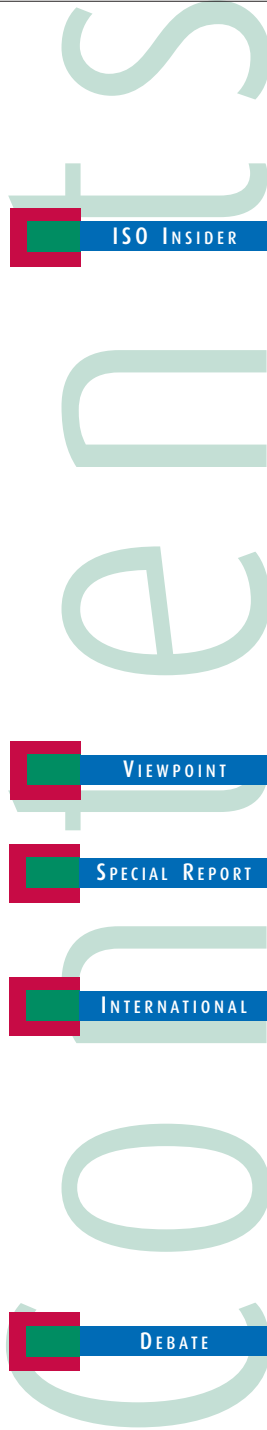
Debate Reactions to ISO Secretary-General's 'police yourselves' call to ISO 9000 community
